How did the Fund perform during the reporting period?


The Fund is offered as a potential bond replacement or complement to traditional bond portfolios. The Fund's strategy is designed to have low to negative correlation to bonds with similar volatility.

Fund Performance

The Fund had a slight decline of -0.58% NAV (-0.52% closing market price) since its inception on December 18, 2023. The Bloomberg Aggregate Bond Index was up 5.34% over the same period.

The Fund allocates to multiple alternative strategies that provide income and negative correlation to each other. The Fund has allocated assets to a long/short high dividend vs cap weighting strategy, options strategy, long/short volatility, managed futures and a carry strategy. The Fund's highest contributors to the portfolio over the reporting period were the long market volatility strategy, options strategy and the long volatility strategy. The lowest performers were the managed futures and long/short high dividend vs cap weighting strategies. Since this strategy is a stand-alone alternative fund, the Fund does not expect to track any index and any given time. The Fund established a 5% distribution yield on July 27, 2024, based on the income producing strategies in the portfolio.

Since the Fund is expected to have a low to negative correlation to the bond markets, the performance was as expected.
